The authors have significantly improved the manuscript. I am still not convinced that the approach the authors chose is the best to address off/on target effects, but I think, having toned down their claims, their conclusions are supported by their data. It would be nice if the authors could include a similar paragraph as in the response to the reviewers regarding the differences of targeting nuclease activity vs methyltransferases.
